### 1. Abstract

*This template gives formatting guidelines for Extended Abstract Format for Conceptual paper. The submission topic must be related to the i-GREduc 2023 conference theme: Critical Thinking and Problem Solving: Empowering the Next Generation of Learners. The authors must use the template given for the paper to be accepted. Extended abstracts should be written according to the underlying structure of the structured abstract and in a form that is shorter than the full text. Please avoid scientific or engineering symbols, acronyms and bullets. The abstract should be typed single-spaced in 10-point type italicize Times New Roman. The length should be about 250 words maximum. The abstract should not contain any undefined abbreviations or unspecified references.*

**Keywords:** Keyword 1; keyword 2 (List three to five pertinent keywords specific to the article)

### 2. Text Formatting

Manuscripts should be submitted in Microsoft Word file (\*.doc/\*.docx), A4 size, and single-spaced in 11-point type Times New Roman with custom setting margins (Top=1.80cm, Bottom=1.80cm, Left=2.50cm, Right=1.80cm). Extended abstracts should be at least three pages, but not more than five pages in length including the references. Word limit is 1500 - 2,000 words.

#### 1.0 Heading 1: use this style for level one headings

Paragraph: use this for the first paragraph in a section, or to continue after an extract.

New paragraph: use this style when you need to begin a new paragraph.

Display quotations of over 40 words, or as needed.

## 2.0 Abbreviations

Abbreviations should be defined at first mention and used consistently thereafter.

## 3.0 Formula and Equation (if any)

It should be noted that all easily confused characters and symbols, upper-case and lower-case letters, as well as block and italicized lettering should be noticed to the proceedings editor.

## 4.0 Tables and Figures (if any)

Figures and tables should be placed in suitable spaces. The tables should also be numbered like Table 1, 2, 3...etc and same as the figure. Figure captions should be centred below the figures; table captions should be centred above. Obtain permission and include the acknowledgement required by the copyright holder if a table or figure is being reproduced from another source.

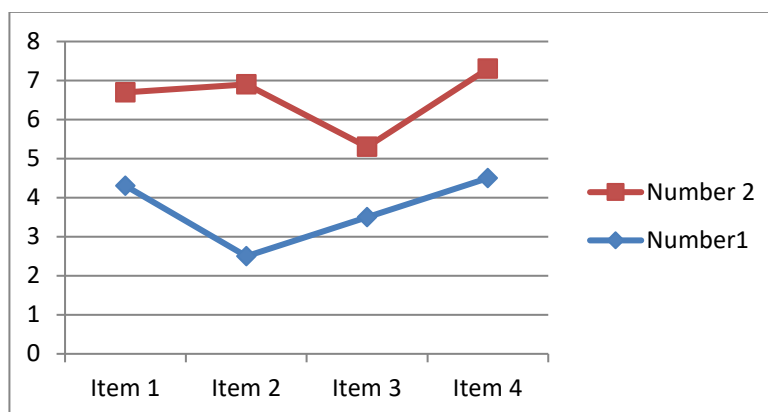


Figure 1. Type your caption here.

## 3. Acknowledgements

7. Reference list:

The list of references should only include works that are cited in the text and that have been published or accepted for publication. Personal communications and unpublished works should only be mentioned in the text. Do not use footnotes or endnotes as a substitute for a reference list. Reference list entries should be alphabetized by the last names of the first author of each work. Please use the APA (American Psychological Association) referencing style.
