Selected papers for the conference are expected to be published in reputable journals (SCOPUS Indexed Publications).

Format for Abstracts

All submission must be in **ENGLISH** and not more than 250 words in length.

Double spacing on A4 size paper (210 mm X 297 mm) in Microsoft Word or PDF format.

Author/co-author(s) name(s), title(s), position(s), organisation(s) and contact address(es) (including email address(es)) should be provided in the abstract.

The presenting author's name must be underlined.

Submission of email address(es) is essential. Most, if not all correspondence shall be carried out via email.

Deadline for Abstracts

Extended to 31st January 2019

Deadline for Full Papers

Authors will be informed of the acceptance of their abstracts via email by 15 February 2019.

Deadline for full paper submission is **31 March 2019**. Full paper must be submitted in a Microsoft Word and PDF format according to the Guidelines for Full Paper Submissions that will be uploaded onto the official website.

Again, authors will be informed of the full paper acceptance via email by **01 May 2019**.

Author(s) of accepted full paper need to prepare a camera-ready (final) version for inclusion in the Conference Proceedings. Cameraready (final) version will be substantially the same as the full paper but will take into account reviewer's comments. Camera-ready (final) version must be submitted via email by **01 June 2019**.
